Some Oregon OSHA general industry, maritime and construction rules for personal protective equipment reference ANSI consensus standards Z87.1-1989 and Z87.1-1968. This rulemaking removes those older standards and will recognize ANSI/ISEA Z87.1-2010, ANSI Z87.1-2003, and ANSI Z87.1-1989 (R-1998).

The ANSI/ISEA Z87.1-2010 provides requirements for the selection, testing, use, and maintenance of protectors intended to minimize or prevent eye and face injuries including impact, non-ionizing radiation, and chemical exposures in occupational and educational environments. ANSI Z87.1-2003 and ANSI Z87.1-1989 (R-1998) are prior versions of this standard which are also incorporated by reference as alternative means of compliance with Oregon OSHA's eye and face protection requirements.

#### **Fiscal and Economic Impact:**

This rulemaking will not impose any additional or more stringent requirements on employers. Employers can comply with the final rule by following their current usual and customary practice in providing eye and face protection to their employees. This final rule expands the options available to employers without removing any existing option and thus has no costs. Therefore, the final rule is not economically significant.

#### Statement of Cost of Compliance:

#### 1. Impact on state agencies, units of local government and the public (ORS 183.335(2)(b)(E)):

Oregon OSHA's own cost in administering the rules are limited to the rulemaking itself. All state agencies as well as units of local government are affected in the sense that they are employers under the Oregon Safe Employment Act.

This rulemaking imposes no additional costs on any private-sector or public-sector entity.

#### 2. Cost of compliance effect on small business (ORS 183.336):

a. Estimate the number of small business and types of businesses and industries with small businesses subject to the rule: All small businesses and types of business and industries with small businesses who are subject to the Oregon Safe Employment Act and who use personal protective equipment are subject to the rules.

# b. Projected reporting, recordkeeping and other administrative activities required for compliance, including costs of professional services:

There are no additional reporting, recordkeeping or other administrative activities required for compliance with these rules.

#### c. Equipment, supplies, labor and increased administration required for compliance:

No additional equipment, supplies, labor or increased administration is required for compliance with these rules.

#### How were small businesses involved in the development of this rule?

Federal OSHA developed these rule changes in cooperation with the Advisory Committee on Construction Safety and Health. Federal OSHA received no significant adverse comment to the proposed rule changes.

The nature of this rule change is to update reference standards and the rule itself is not significantly changed, so it was not necessary to form or consult an advisory committee.
