Oregon OSHA - Adopted Changes Consensus Standards In Maritime/Shipyard Employment

Oregon OSHA adopted the Federal OSHA changes as they appear in the October 17, 2006 Federal Register. These changes enhance the fire protection in shipyard employment standard (Division 5, Maritime, CFR 1915) by requiring employers to comply with the newer standards, which may be even more protective than the older standards. Federal OSHA states these changes do not result in additional compliance costs. Although Federal OSHA has jurisdiction over most marine activity, Oregon OSHA must remain at least as effective as the federal standard. Therefore, we adopted the federal changes in Oregon.

This is OR-OSHA Administrative Order 1-2007, **adopted January 9, 2007 and effective January 16, 2007.**
