Changes Adopted - Maritime Fire Protection in Shipyard Employment

Federal OSHA published, in the [September 15, 2004 Federal Register](#), changes to 29 CFR 1915, Occupational Safety and Health for Shipyard Employment. Oregon OSHA's standards must be at least as effective as federal OSHA, therefore, we are proposing to adopt the changes as published. These changes are in OR-OSHA's Division 5, Maritime Activities, and creates a new subpart P in 29 CFR 1915.

The new final standard, Fire Protection in Shipyard Employment, was developed through the negotiated rulemaking process and will provide increased protection from fire hazards for workers in the shipbuilding, ship repair and ship breaking industries. The standard reflects new technologies and current national consensus standards. It also gathers all fire-related safety practices for shipyard employment into a single subpart, which will make them more accessible and understandable for employers and employees.

This is OR-OSHA Administrative Order 8-2004, **adopted and effective December 30, 2004.**
