Program Directive A-22

SUBJECT: Electrical Products Approval

AFFECTED STANDARDS/

DIRECTIVES: Division 2, Subdivision S, Electrical

PURPOSE: The purpose of this directive is to inform all Oregon OSHA personnel of recognized Electrical Testing Laboratories.

BACKGROUND: I-Bulletin I-44, dealing with approval of electrical products, listed only three testing laboratories approved by the State of Oregon Department of Commerce. Program Directive A-22 was written to replace I-44 with a complete list.

ACTION: Listed on the following pages are the names and addresses of the Testing Laboratories that have been either approved or conditionally approved by the State of Oregon, Building Codes Division, as meeting the testing standards for minimum electrical safety as required by Oregon Revised Statutes 479.510-479.855 and Oregon Administrative Rules 918-307.
