This year we are excited to offer the annual Western Pulp, Paper, & Forest Products Safety & Health Conference in person again! The conference is the only safety conference offered to the pulp, paper, converting, and forest products industries that is created by labor, management, and government working together for the greater good... ***Partners in Safety and Health – Yesterday, Today, and Tomorrow***. The Conference committee consists of members representing the industry -- local unions, mill safety management, contractors, and government agencies. This is the 31st year!

Past attendance has exceeded 450 people and the event has offered more than 50 educational breakout sessions, roundtables, and more than 40 exhibit booths showing the latest safety and health products and services.

More than ever, the Conference needs the continued financial support from the local unions, mills, contractors, and products/service vendors in the industry. Costs to hold the conference increase each year and we want to keep the registration fee as low as possible. Your support is a key element in the continual development of the high-quality conference we have all grown to expect.
