**Cranes and Derricks in Construction** – Ron provided an update. Proposal was submitted adopting the Federal Standard with addition of our Fall Protection changes. Publication is currently being developed and should be out by February 1, 2011. The advisory committee will meet again to finalize the publication. Federal OSHA has published their final rule (Note - It is in a different format but no changes were made.). In Subdivision N, the demolition portion was removed to form sub-part DD, Cranes and Derricks Used in Demolition and Underground. (Subpart CC is Cranes and Derricks in Construction.) Public hearings will be held on January 13<sup>th</sup> at OR-OSHA Portland Field Office and on January 14<sup>th</sup> in Springfield at the Oregon Forestry Department. Adoption will be effective February 9, 2011.
