Definition of the a non-entry firefighter is any one of the following:

No SCBA, no fit test, no flow test, no medical evaluation, and 4 people will not reliable be at all emergency scenes.

PPE Hazard Assessment

Conscious decision on how to protect employees

Stay up wind, take a defensive posture, evacuate

Use the IRPG fuel model for response

PPE Requirements:

Helmet, gloves, eye protection, follow appropriate manufacturer instructions for identify when equipment should be replaced.

Employer's and employee responsibilities from 2/L

Appropriate Training:

ICS100, 200, 700

Basic Wildland is optional based what organizational statement states on types of service If this is chosen, the requirements from 437-007-1325(4)(a-c)

National Incident Management System

NFPA Orientation and Safety

NFPA Fire Behavior

NFPA Protection Clothing

NFPA Fire Dept Communications & Size up

NFPA Water Supply & Streams

NFPA Fire Control & Wildand Urban Interface

NFPA S-216 Driving for the Fire Service

Follow requirements from 437-007-1325(1-3)

Consider hose testing requirement from wildland requirements (at factory), and possibly use language from 437-001-0760 for inspection frequency. Another option, Equipment should follow appropriate manufacturer's instructions.

Non-Entry Firefighters can not entry firefighting equipment

Entry Firefighters can not use non-entry equipment

No equipment on the non-entry apparatus should be used for emergent interior operations.

Thanks were given for all that participated in this work group. It will take some time for a draft to be put together, but expect something June or July. Once the group has had the opportunity to review the draft, it will be presented to the larger Fire Service Advisory Group that meets quarterly.
